IMMIGRANTS TO AMERICA

Most researchers follow only three 17th century colonial Newberry families in America, THOMAS NEWBERRY in Dorchester, MA circa 1634, RICHARD NEWBERRY in Weymouth/Malden, MA circa 1643, and WALTER NEWBURY, Newport, R.I. circa 1670. There are others who are recorded <u>earlier</u> and some <u>later</u> who have not been studied at all. The "Virginia Patent" which was located around the James River and Chesapeake Bay, had a number of immigrants earlier than those in what is known as New England. What follows is a compilation of sources:

NICHOLAS NEWBERRY

1621 - 11 September,

"John Farrer and Robert Tokely ship goods in the WARWICK, **Mr. Nicholas Newberry**, bound from London to **Virginia** (**PRO:** E190/24/1) English Adventurers and Emigrants."

THOMAS NEWBERRY

1633 – 31 March - *Recovery of London* voyage (See Coldham)

The *Recovery of London*, sailed from Weymouth, Dorset, on 31 March 1633. This ship carried other people associated with the *Mary & John* group of 1630, including Jonathan Gillett and Stephen Terry, returning to New England with their new wives." Thomas Newberry lived at Marshwood (Marshwood Vale) until he sailed for New England. It appears that he made two crossings.

"Planters carrying with them household goods, clothing and provisions for themselves, their wives, children and servants, valued at £920 and allowed to pass free of custom by His Majesty's patent, to be shipped on the *Recovery of London*, Mr. Gabril Cornish, from Weymouth to New England: **Thomas Newbery**, Thomas Long, Davide Phippen, Jonathan Gillet, Elizabeth Parkman, Mary Coggen, Thomas Wakeley, Daniel Norchat, Joseph Androes, Robert Dible, John Pope, Stephen Terrey, Robert Elwell, John Wotts, William Bowne, John Hardy, Sarah Hill, **John Woolcocke**, [Wollcott] Thomas Shawe, Antony Eames, Thomas Swift, George P[---} (possibly Pynchon), Thomas Biscomb, Ezechia Hore, John Elderman, John Pinny. (TNA <u>E190/875/8</u>)."

1634 – 17 April made a run on the *Mary and John* leaving from WEYMOUTH

The 1634 run on the *Mary and John* left from WEYMOUTH. This information was detailed in John
White's diary, but left out of the ships manifest. William Whiteway of Dorchester, Dorset, an associate of Rev. John White, kept a diary (now in the British Museum, London), which states that "1634 April 17,

Mr. Newburgh of Marshwood Vale and many others set sail from Weymouth towards New England". The first record of Thomas in the Dorchester, MA records is on 1 Sept. 1634.

ALICE NEWBERRY

1622 - Arrived in Virginia on the James with William and Elizabeth Rowley (Rowsley) and left England on July 31, 1622. The Rowley household, which included a large group of servants, resided on Jamestown Island (1). A census of the colony's inhabitants reveals that William and Elizabeth Rowley died sometime after april 1623 but before February 16, 1624. One of the Rowleys' maidservants also perished, perhaps Alice Newberry (FER 400; CBE 39).

NEWBY, HENRY

1635 - "16 Junij Theis under-written are to be transported to Virginea imbarqued on the <u>Thomas & John</u>, Richard Lambard Mr, being examined by the Minister de Gravesend concerning their conformities to the orders & Discipline of the Church of England: And tooke the oathe of Allegeance." This follows close on the heels of other Newberry people traveling to New England and the Virginia Patent.


